- The NTTG Management Committee held a meeting today where they discussed the SCG paper
- Rich Bayless sent a letter to Jeff Miller indicating that NTTG could not accept the SCG paper in its current form and direction; the paper needs to undergo major changes prior to receiving the support of NTTG
 - o Jeff Miller responded and indicated that the final draft of the paper can hold out until April
- Jeff is still in the process of soliciting comments and support from the other SPG's
- NTTG needs to be in a position where entities can come to an agreement prior to the meeting in April
- There is a possibility of creating two papers
- Suggested Timeline:
 - The NTTG Steering Committee meeting will take place on March 8th
 - Prior to the meeting, create an outline or concept of the approach we would like to take; this information will be submitted to the Steering Committee for discussion
 - Larry Nordell has volunteered to assist with writing the paper and incorporating information from others; Larry will not be able to start the process until February 21st

Decision: Larry Nordell, Lou Ann Westerfield, John Leland, Curt Winterfeld, BJ Moghadam and Rich Bayless will work together to write the paper. An outline of the approach, direction/content, and structure of a paper that NTTG can support will be given to the Steering Committee for approval during their March 8th meeting.
