Discussion: Report on Ad Hoc subcommittee on cost-benefit allocation methodology

- The Sub-Committee is still in the process of gathering databases to determine an appropriate methodology
- The Western Wind and Solar Generation database report will be released on May 20, 2010; this database could potentially assist the Committee with a methodology
 - A study on the Western Wind and Solar Generation was completed in January; this study process is similar to that of NTTG
 - Although this study looks at different issues, the data will still be useful for the Sub-Committee to analyze as it will provide the most current data

- Brian DeKiep is gathering information on the PGM Interconnection
 - The information will focus on developing a summary of RTOS and the utilized methodologies
- Brian will distribute a copy of the Power Pool press release to the Committee to review
