## Discussion: Review and Acceptance of Previous Meeting's Notes

#### **Discussion: Economic Studies**

- Steven Wallace gave a brief overview of the Economic Studies progress
- The PC1 Base Case has been released by TEPPC for the Grid View model
- The Power Base version of the Base Case has not yet been released
- Ron Schellberg, Jamie Austin and Don Johnson have played an important role in testing the Base Cases on the different platforms
- The requirement is to have the Bases Cases completed by June 30<sup>th</sup>
  - Currently we are on scheduled to meet the deadline as the base cases are fairly straight forward

### **Discussion: Draft Study Plan**

- The NTTG Study Plan document and presentation was distributed to the Planning Committee prior to the meeting for review
- Steven Wallace walked through the Study plan presentation noting that the objective of the transmission study effort is to perform a conceptual study that determines, given a limited number of load and resource scenarios, what general transmission improvements are required to provide a feasible system operation at times of transmission stress ten years in the future
- In the biennial cycle, Northern Tier will more closely associate reliability analysis and economic congestion study in a multi-phase process designed to provide a realistic assessment while examining a broad range of alternative futures
- In the upcoming study cycle, Northern Tier will utilize General Electric's PSLF power flow program to conduct a screening analysis to determine what general transmission additions are needed to allow reliable system operation
