Discussion: Review Notes from the August 3, 2009 Cost Allocation Meeting and Approve to Post

Discussion: Planning Committee Economic Studies Review with Ron Schellberg and Jamie Austin

- The economic studies were based upon WECC's PC1A case. The case contained heavy wind to meet the RPS forecast for 2017.
- By adding the projects within the NTTG footprint congestion was mitigated within the footprint, but stresses were noticed in the external areas to the south, particularly at COI and TOT2C.
- Not every proposed project was included in the study. The NTTG study process requires an
 identified source and sink. Not all proposed projects had those identified at the beginning of
 NTTG's biennial planning process.
- These current economic studies do not include any regional economic friction factors that WECC is considering adding to the base cases.
