Decision: Approval of August 7, 2019 NTTG Planning Committee Meeting Notes

- With a motion by Jared Ellsworth and seconded by Rikin Shah, the August 7th NTTG Planning Committee Meeting Notes were **approved by all three Classes**.

Discussion: 2019 Economic Study Request (ESR)

- Review Changes to Draft ESR report that were submitted subsequent to the August 7 Planning Committee
 - Ron Schellberg explained the redlined blue text were revisions made following the August 7th Planning Committee and the red text were those edits made as a result of stakeholder comments received.
 - Chelsea walked through the revisions made to the ESR report subsequent to the August 7th Planning Committee meeting which were made based on discussions during that meeting.
 - The report now includes and executive summary, discussion and conclusion sections.
 - Throughout the report language was changed or added for clarification in assumptions, what lines are getting impacted as well including a production cost analysis section with details on the production runs and clarifying path implications.
- Walk through of stakeholder comments, NTTG's response and any further revisions to the ESR Report
 - NTTG received a number of comments from the Joint Parties.
 - Chelsea Loomis walked through the Joint Parties comments and NTTG's responses.
 - With regards to <u>Figure 25 referenced in Comment ID 36</u>, clarification was asked around the outage flow levels of the ESR case versus the Draft Regional Transmission Plan (DFRTP).
 - It was explained that the two configurations had different capabilities and that the ESR configuration stared out with 1,7000 MW with a limit of 1,850 MW.



Also, the ESR configuration had ho alternative path to support Path C, where as the DFRTP had Gateway South project picking up a portion of the increased transfer.
