Discussion: NTTG 2018-2019 Revised Draft Final Regional Transmission Plan - Stakeholder **Comments and NTTG's Response**

- NTTG received one set of comments from the Joint Parties, whose focus was on the Economic Study Request analysis and the draft report.
- Chelsea Loomis walked through the comments and NTTG's responses.
 - Based on the comments received, no changes were made to the Revised Draft Final Regional Transmission Plan.

Discussion: Project Sponsor Pre-Qualification Process Update

- Although there is a strong inclination the new Regional Planning Organization's efforts filed with FERC will move forward at the beginning of 2020, the NTTG Transmission Providers are still bound by the current Attachment K obligations. In Quarter 8, NTTG opens the window for Project Sponsors to submit pre-qualification data.
- NTTG's Planning and Cost Allocation Committee's are responsible for administering the review of any submitted pre-qualification data including confidential data.
 - To relieve the administrative burden in assessing the data, as done last cycle, the resolution below is asking for the Chairs and Vice-Chairs be designated with that responsibility.

 On October 30th the NTTG Cost Allocation Committee will be meeting to review the same sponsor pre-qualification process to authorize the Cost Allocation Committee Chair.

- December 19th the Steering Committee will meet in Boise, ID to approve the Final Plan.
