Discussion: Approve October 14th, 2009 Meeting Notes to Post

Discussion: Regional Update

- FERC request for comments & NTTG's position (planning issues)
 - FERC has made observations and conclusions from the Technical Conferences from September 2009. They have released a NORC for further feedback.
 - The NTTG Steering Committee has provided a recommendation that NTTG should provide detailed and specific responses to FERC's NORC on regional planning and cost allocation. These responses will create a clear record of NTTG's position on these issues.
 - Most of the regional planning issues in the West will be handled through the DOE FOA Proposal.
 - With input from Jeff Miller, ColumbiaGrid and NTTG are aligned in their approach to the responses to FERC. ColumbiaGrid is responding with the message that FERC's concerns with regional planning will be addressed in the DOE FOA Proposal and this new set of processes should be given time to be implemented before FERC supplements with any additional processes.



- The Cost Allocation Committee is also providing Rich Bayless with input for the NORC comments.
- Rich Bayless reviewed his draft of responses with the Planning Committee. Any additional feedback is due to Rich Bayless by COB Thursday, Oct 29th.
- The Management Committee will review the draft on November 2nd, with the Legal Work Group finalizing the draft by November 6th and submission to FERC on Nov 9th.
- WECC regional planning initiative
 - The Sub-Regional Coordination Group is currently preparing the group's charter and process plan. Drafts will be reviewed at the group's meeting scheduled for Nov 18th, in conjunction with the TEPPC meeting. The goal is have the charter and process plan approved at WECC's December Board meeting.
 - Rich Bayless will circulate drafts of the charter and process plan when they become available to the Planning Committee for feedback.
 - o There has been no word on the award for the DOE FOA application.
 - A task force has been set up to look at roles relative to regional planning and the potential splitting of duties between TEPPC and PCC.
- TEPPC 2009 study program
 - TEPPC is currently fine tuning the data for the 2019 base case for economic and congestion studies.
 - This base case will be the basis for NTTG's economic studies for the next study cycle.
- Wind Integration Study Team
 - The Wind Integration Forum will hear a status report from the WIST Team at their upcoming meeting.
 - Ron Schellberg gave a presentation on his independent analysis of wind integration, and load and respective patterns with use of supplemental generations, in an effort to integrate wind better.
 - Through his analysis, closer-in, albeit lesser quality wind, was more economic to integrate than farther out, higher quality wind resources.
 - WIST is developing dynamic scheduling limits between key flow gate and balancing areas for the Northwest.
 - BPA is working on the methodologies for this effort.
 - Initial limits need to be identified by the time the Joint Initiative's DSS is operational (Q2 2010.)
 - Paul Arnold is the WIST liaison to the VGS. WIST is looking to align with the VGS and their work.
- Other regional activities
 - There is a TEPPC call next Tuesday, Nov 10th. The Planning Committee will need to provide guidance to Rich Bayless so he can give an update on the committee's activities.

Discussion: ColumbiaGrid Update

- ColumbiaGrid is approaching the end of their biennial cycle. They are currently finalizing their biennial report that is due by the end of 2009.
- ColumbiaGrid will be creating two study teams. One team will look at the Olympic Peninsula and another team will evaluate the north and south paths of the Cross Cascades projects.



- ColumbiaGrid will soon be having a kick off mtg for parties interested in scoping a broad open season. ColumbiaGrid is looking for active participation from NTTG members.
- ColumbiaGrid is shelving the effort to be a NERC planning authority. There does not seem to be enough need for this service.
- ColumbiaGrid is combining local providers' Attachment K meetings with a sub-regional level meeting, in an effort to reduce the number of meetings required in their footprint.
