Discussion: Right Sizing

- This topic is gaining momentum locally and nationally. There are many unknowns so it makes it difficult to know how to approach the issue, but flexibility is needed.
- Transmission planning is innately long term and looking at the different options for building is needed to be looked at from a cost allocation perspective
- Caution will be followed to ensure that the Cost Allocation Committee adheres to their
 charter. The focus will remain on the cost allocation process and how costs are allocated, not
 whether an overbuild of the line itself is prudent. The Planning Committee and the Steering
 Committee will be involved as different aspects of the right sizing issue are addressed.
- The Cost Allocation will continue to proactively work on developing a response to the right sizing issue as needed. This will also fulfill the educational role the committee needs to perform on behalf of the NTTG membership.
- Decisions for municipalities are imminent, so if entities want to weigh in on the topic, responses should be worked on sooner rather than later. It will be difficult to change or affect decisions after they have been made.
- This topic will be included on the agenda for the next few meetings. The document written by Larry Nordell and Matt Muldoon will continue to be reviewed and revised. This document will hopefully become a white paper.
