- Planning Committee
  - The Heavy Summer base case is released for contingency analysis.
  - The Light Autumn base case should be released at the end of this week.
- Transmission Use Committee
  - The committee is on track for the January deliverables.
  - The current work is refining and organizing the data collected for presentation at the January Stakeholder meeting.
- Economic Study Requests: Submittal Timeframes
  - TEPPC's window for submitting study requests is November through January.
  - o NTTG's window for submitting study requests is January through March.

### **Discussion: Webinar**

- The two major issues raised at the November 12<sup>th</sup> webinar in regard to cost allocation were right sizing and reliability.
  - o The right sizing issue will continue to be discussed by the Cost Allocation Committee.
  - NTTG's Cost Allocation Committee does not assign reliability or value to a project.
     NTTG does not possess the rate structure for that process.

#### **Discussion AWEA/RNP Filing**

- AWEA and RNP's concerns regarding NTTG's cost allocation process seem to mostly stem
  from a misunderstanding between cost allocation and cost recovery. NTTG does not have the
  authority to assign cost recovery processes.
- NTTG will encourage AWEA and RNP to actively participate in the Cost Allocation Committee
  calls and the NTTG Stakeholder meetings as a forum to assist in their understanding of
  NTTG's structure and processes and hopefully satisfy some of their concerns.
- The 2008-09 Biennial Plan is NTTG's first iteration of the planning process. It is important to get through this first iteration to have the process evolve before looking at large revisions to the process.
